Proponents in attendance at the site visit have submitted comments/concerns regarding the requirement in the specifications to make the ice lights dimmable. The municipality is posting this addendum to request that proponents submit a "SCHEDULE C – BID FORM & PROPOSED SCHEDULE of WORK" that provides pricing on an Option A – Per specifications in the current RFQ document (dimmable ice lights), as well as Option B – pricing for the scope of work without the requirement for the ice lights to be dimmable. In both cases the same ice lights are provided, but in Option A they are installed with dimming capability, and in Option B they are installed without dimming capability. Therefore, below is the updated 'SCHEDULE C' that shall replace the 'SCHEDULE C' in the original RFQ document.
