Note that, contract pricing may be adjusted using unit pricing included in the Pricing Sheet. Inclusion of non-eligible source recycling services at the curb in 2025 is provisional on pricing and Council approval, and total pricing as indicated above may be adjusted based as needed.

Pricing for a contract extension in 2026 will be adjusted to account for the non-eligible source material services approved by Council (as priced in items 9, 10, 11, 12, and 13), based on this RFQ and other considerations.

Note that the Municipality will pay for collection of front-end bins of garbage and recycling, per stop as priced in the pricing schedule. Businesses will be responsible for paying the Contractor directly for their own bin rental costs at the rates included in the unit pricing schedule below. If a business chooses not to engage the Contractor for supply of bin, the contract price will be adjusted to note the removal of this bin from the municipal collection program.
