

MUNICIPALITY OF CENTRAL MANITOULIN

BY-LAW NUMBER 2024-28

BEING A BY-LAW TO AUTHORIZE THE ROAD DEPARTMENT OF THE MUNICIPALITY OF CENTRAL MANITOULIN TO ERECT A TRAFFIC CONTROL SIGN IN A SPECIFIC AREA OF THE MUNICIPALITY.

WHEREAS Section 11 (3) of the Municipal Act, 2001 S.O. 2001, CHAPTER 25 and amendments thereto empower municipalities to pass by-laws, subject to the rules set out in subsection (4), respecting matters concerning Highways, including parking and traffic on highways.

AND WHEREAS the Council of the Municipality of Central Manitoulin deems it advisable to erect traffic control (NO PARKING) signs at the following location:

Both sides of the Monument Road North, adjacent to Stanley Park Tent and Trailer from 700 metres North of Tracy Road to 1000 metres North of Tracy Road.

THEREFORE, THE COUNCIL OF THE MUNICIPALITY OF CENTRAL MANITOULIN ENACTS AS FOLLOWS:

1. That No Parking signs be erected at the location listed above;
2. That no person shall park on either side of the Monument Road North, adjacent to Stanley Park Tent and Trailer from 700 metres North of Tracy Road to 1000 metres North of Tracy Road;
3. And that this by-law becomes effective on the date of its passing.

4. Enforcement Penalties

- 4.1 Any person who contravenes or fails to comply with any provision of this By-Law is guilty of an offence and upon conviction is liable to a fine as provided by the Provincial Offences Act, R.S.O. 1990, Chapter P.33. (See Schedule "A" and "B").
- 4.2 No person shall hinder or obstruct or attempt to hinder or obstruct an officer who is exercising a power or performing a duty under this By-Law.
