

**MUNICIPALITY OF CENTRAL MANITOULIN**

**BY-LAW NUMBER 2024-29**

---

**BEING A BY-LAW TO AUTHORIZE THE ROAD DEPARTMENT OF THE MUNICIPALITY OF CENTRAL MANITOULIN TO ERECT A TRAFFIC CONTROL SIGN IN A SPECIFIC AREA OF THE MUNICIPALITY.**

WHEREAS Section 11 (3) of the Municipal Act, 2001 S.O. 2001, CHAPTER 25 and amendments thereto empower municipalities to pass by-laws, subject to the rules set out in subsection (4), respecting matters concerning Highways, including parking and traffic on highways.

AND WHEREAS the Council of the Municipality of Central Manitoulin deems it advisable to erect traffic control (NO PARKING BEYOND THIS POINT) signs at the following location:

“No parking beyond this point” Sign at the intersection of Point Simcoe Road and Munro Street.

THEREFORE, THE COUNCIL OF THE MUNICIPALITY OF CENTRAL MANITOULIN ENACTS AS FOLLOWS:


1. That No Parking beyond this point sign be erected at the location listed above;
2. That no person shall park at or beyond the intersection of Point Simcoe Road and Munro Street;
3. And that this by-law becomes effective on the date of its passing.

**4. Enforcement Penalties**

- 4.1 Any person who contravenes or fails to comply with any provision of this By-Law is guilty of an offence and upon conviction is liable to a fine as provided by the Provincial Offences Act, R.S.O. 1990, Chapter P.33. (See Schedule “A” and “B”).
- 4.2 No person shall hinder or obstruct or attempt to hinder or obstruct an officer who is exercising a power or performing a duty under this By-Law.
